I acknowledge that I am over 18 years of age or I am completing membership on behalf of a person under 18 years of age in the capacity as their legal parent or guardian and I consent to this risk acknowledgement and release on their behalf.

I acknowledge and understand that whilst participating in Cycling activities:

- I may be injured, physically or mentally, or may be killed, or my personal property may be lost or damaged.
- Other persons participating in Cycling activities may cause me injury or may damage my property, or I may cause injury to other persons or damage their property.
- The conditions in which the Cycling activities are conducted may vary without warning.
- I may be injured or die or suffer damage to my property as a result of the negligence or breach of contract of Spokes Cycle Club Inc.
- I assume the risk and responsibility for any injury, death or property damage resulting from my participation in Cycling activities.
- To the fullest extent permitted by law, I release and indemnify Spokes Cycle Club Inc against all and any actions or claims which may be made by me or on my behalf or by other parties for or in respect of or arising out of any injury, loss, damage or death caused to me or my property whether by negligence, breach of contract or in any way whatsoever.
